Financial Planning & Wealth Management (FPWT) – Information for Prospective Students Agreement

Students who wish to apply to study in the Financial Planning & Wealth Management (FPWT) Ontario Graduate certificate program are required to carefully read this agreement and must sign below indicating they fully understand and accept the terms and conditions of studying within the FPWT program.

Agreement Terms

Students are required to purchase the course materials for the Investment Funds in Canada (IFC) course and will receive one (1) attempt at the Investment Funds in Canada licensing exam for a cost of \$435. This course is offered in the second term of the program and this fee is mandatory, in addition to the student's tuition.

Student **can also choose** to enrol in the Canadian Securities Course (CSC)[®], the Conduct and Practices Handbook (CPH)[®] Course and/or the Canadian Insurance Course (LLQP) on a voluntary basis.

Please Note: Enrolment in the Financial Planning & Wealth Management program **does not** constitute enrolment in the actual licensing course(s) offered by MAGE or the Canadian Securities Institute (CSI). Separate registration and fees determined by the licensing association will apply and the additional registration fees are not included in the tuition for the Financial Planning & Wealth Management program. ¹
